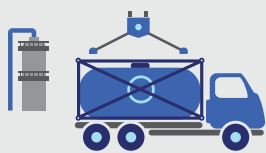


# OUR TANKS

We own special ISO Liquid Cargo Containers to be used for multi-modal logistics. The inner material of these ISO containers is stainless steel and the outer jacket is carbon steel. All containers are made as per ISO standards and are designed and tested in accordance with IMDG, CFR/49, RID/ADR and comply with US-DOT.

**Our tanks are insulated with steam heating facility, have pressure valves for top loading and bottom discharge, suitable for all types of liquid cargo.**

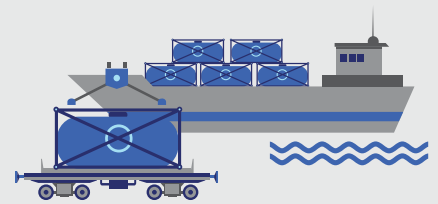
## MODUS OPERANDI

Containers are stacked at the siding yard



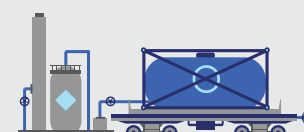
Containers are loaded on rakes and transported to the plant

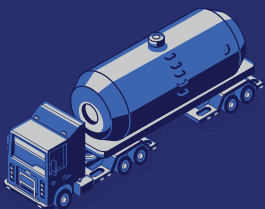

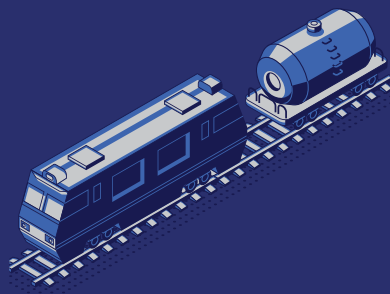
